SMALLBURGH PARISH COUNCIL

Minutes of the meeting of the Parish Council held on the 14th January 2020 in the village hall, commencing at 7:45p.m.

Present: Councillors Mrs. A Cousins, Mr. R Debbage, Mr. K Wilby, Mr T. Colman & Mr T. Hardingham.

In attendance: J Butler, Parish Clerk, six members of the public & Councillor Dixon (NCC & NNDC).

- 1. APOLOGIES FOR ABSENCE Cllr T. Urwin (Chairman) & Cllr C. Dean (Vice Chairman). It was unanimously agreed that Cllr A. Cousins chair the meeting.
- 2. MINUTES OF THE LAST MEETING The minutes of the last meeting were approved and signed as being a true record of the business of the meeting.

- 5. PUBLIC PARTICIPATION, COUNTY & DISTRICT COUNCILLOR REPORTS/POLICE REPORT

Public – nothing raised.

Cllr Dixon reported that he supports the village plan.

NCC budget is being prepared, proposals look like a 2% increase to fund additional demands on Adult Social Services and 1.99% increase on other services totalling 3.99% overall increase. NNDC precept - cannot confirm what this is likely to be but is likely to increase. The Police will also need to decide on their funding costs.

NCC - consultation on boundaries has resulted in the number of NCC Councillors remaining at 84. Due to population changes there is likely to be a small change to boundaries to equal out the number of residents in each ward. Smalburgh is unlikely to change. Jon Winnett, Highways Engineer leaves 17th January and Justin Lemay commences in the role.

NNDC – The new corporate plan has been outlined and further detail will be confirmed in the near future. A management restructure has seen 2 posts of Director reducing to 1 post. This has caused some unrest in the Council. A new refuse collection contract has been agreed but not published as yet as the decision is made in confidence and is subject to a 10-day call in period where it could be challenged. This period has passed therefore the decision should be published soon.

"Smallburgh Parish Council do not object nor support this application. We note that previous applications have been rejected due to Highways concerns over potential increases in traffic and visibility for people pulling into and out of access points on this stretch of road. We are therefore concerned with the inconsistency in Highways responses as they do not object to this application but have objected to others nearby on the basis of either resulting increase in traffic or poor road visibility from the access point when pulling out on to the road or turning into it. As a parish we are hoping to seek clarity on what process, rules and policies Highways apply so that we can better understand their approach and will contact them separately to achieve this."
